ORDER

- 1. The Chairman, The Charitable and Educational Welfare Society, Pathanamthitta vide paper read (1) above, had applied for starting new medical college with MBBS course. The application was processed by the University and the inspection Commission constituted by this University vide paper read (2) above had recommended to start MBBS course and consent of affiliation was granted for the same.
- 2. As per paper read (3) above, the Ministry of Health and Family Welfare has granted permission for starting new, Mount Zion Medical College Hospital, Pathanamthitta by The Charitable Educational and Welfare Society with MBBS course having an annual intake of 100 (One Hundred only) seats for the academic year 2014-15. The Chairman, The Charitable Educational and Welfare Society has remitted an amount of Rs. 10,00,000/- (Rupees Ten lakh only) towards the Provisional affiliation fee and Rs. 20,00,000/- (Rupees Twenty lakh only) towards Refundable Deposit for starting new medical college vide order read (4) above. The college has submitted an undertaking in Kerala Stamp paper worth Rs. 100/- agreeing to abide by the rules, regulations, orders, circulars and instructions of the Kerala University of Health Sciences, Central, state governments and the respective statutory councils.
- 3. Sanction has therefore been accorded by the Principal Secretary to Government, Health and Family Welfare Department in charge of the Vice Chancellor, in exercising the powers conferred under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant provisional affiliation for starting new Mount Zion Medical College Hospital, Pathanamthitta by Charitable Educational and Welfare Society with MBBS course having an annual intake of 100 (One Hundred only) seats during the academic year 2014-15 subject to conditions mentioned below:
 - 1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.

- 2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3. Affiliation granted is strictly provisional and only for the academic year 2014-15. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 5. The College should host its own website showing the detailed list of faculties.
- 6. The College should remit Annual Administration fee of Rs. 7,50,000/- (Rupees Seven lakh fifty thousand only) after closure of admission for the academic year 2014-15.
