## **ORDER**

University vide paper read (1) above, invited applications for continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, Mount Zion Medical College Hospital, pathanmthitta-MM029 has submitted application for the continuation of provisional affiliation for the year 2017-18 vide paper read (2) above.

- 2) On verification of the applications it is found that the college has remitted prescribed fee for continuation of provisional affiliation for the year 2017-18 and submitted necessary documents except the renewal permission from Medical Council of India for the year 2017-18. The Medical Council of India had denied permission to the college for making admission to MBBS course during the year 2017-18 but the admissions had been made at the college based on the orders of the Hon'ble High Court of Kerala.
- 3) The Ministry of Health and Family Welfare, Govt of India vide paper read (3) above, in terms of judgement in WP(C) No. 825/2018 dated 22-09-2017, had regularized the admission of students admitted to MBBS course at Mount Zion Medical College Hospital,pathanmthitta during the year 2017-18 and vide paper read (4) above, has granted recognition to Mount Zion Medical College Hospital,pathanmthitta for conducting MBBS course with an intake of 100 seats.
- 4)The Governing Council vide paper read (5) above, has decided to grant Continuation of Provisional Affiliation to Mount Zion Medical College, Pathanamthitta for conducting MBBS course with an intake of 100 seats during the academic year 2017-18 and to regularize the admissions made in the year 2017-18 based on the recognition issued by the Ministry of Health & Family welfare.
- 5) Sanction,has therefore been accorded by the Hon,ble Vice-Chancellor to implement the decision of the Governing Council and to grant continuation of provisional affiliation to Mount Zion Medical College Hospital, Pathanamthitta for conducting the following course with an annual intake of students mentioned against it during the academic year 2017-18 and to regularize the admissions made at the college during the year 2017-18 subject to the conditions detailed below:-

- 1 Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 The College should remit annual administration fee fixed for UG/PG course for the academic year 2017-18
