***ORDER**

As per paper read (1) above, the University invited applications for continuation of provisional affiliation for the academic year 2020-21 from colleges for courses affiliated to the University. The Principal, Mount Zion Medical College, Pathanamthitta, vide paper read (2) above, has submitted application for the continuation of provisional affiliation for MBBS course with an intake of 100 seats for the academic year 2020-21.

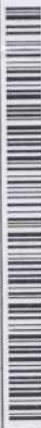
2) On verification of the applications it is found that the college has submitted necessary documents and remitted fee for the Continuation of Provisional Affiliation for the year 2020-21. The Inspection commission, vide paper read (3) above, has submitted inspection report after conducting the inspection. After scrutinizing the inspection report, the Scrutiny Committee vide paper read (4) above, has pointed out that there is deficiency of one Associate professor in the department of Biochemistry and one Tutor in the department of Physiology and recommended to grant Continuation of Provisional Affiliation to the college for the year 2020-21. The Governing Council, vide paper read (5) above, has decided to grant Continuation of Provisional Affiliation to Mount Zion Medical College, Pathanamthitta for MBBS course with an intake of 100 seats for the academic year 2020-21. The college, vide paper read (6) above, has obtained renewal recognition from the Ministry of Health & Family Welfare for conducting the MBBS course for the Academic year 2020-21.

3) Sanction, has therefore been accorded by the Hon'ble Vice-Chancellor by implementing the decision No. 59.07 of 59th meeting of the Governing Council to grant continuation of provisional affiliation to Mount Zion Medical College, Pathanamthitta for conducting the **MBBS course with an annual intake of 100 seats** during the academic year 2020-21 subject to the conditions detailed below:

1 The college should rectify the deficiency of one Associate professor in the department of Biochemistry and one Tutor in the department of Physiology and should submit the compliance report to the University with necessary credentials.

Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.

2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.





3 Affiliation granted is strictly provisional and only for the academic year 2020-21. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

4 The College should remit annual administration fee fixed for UG/PG/Super Speciality courses for the academic year 2020-21 and the college should submit the order reconstituting the College Council for the Academic year 2020-21 at the time of Student Registration

5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
