## ORDER

As per paper read (1) above, the University had invited applications for Continuation of Provisional affiliation for the academic year 2022-23 from colleges for courses affiliated to this University. The Principal, Mount Zion Medical College Hospital, Pathanamthitta had submitted applications for the Continuation of Provisional Affiliation for the academic year 2022-23 vide paper read 2. On verification of the applications, it is found that the college had submitted necessary documents and remitted fee for the Continuation of Provisional Affiliation for the academic year 2022-23. 3. University had posted inspection at Mount Zion Medical College Hospital, Pathanamthitta in connection with the Continuation of Provisional Affiliation for the academic year 2022-23. Accordingly, the inspection commission submitted inspection report after conducting the inspection, vide paper read (3) above. 4. After scrutinizing the inspection report, the Scrutiny Committee recommended granting of Continuation of Provisional Affiliation to Mount Zion Medical College Hospital, Pathanamthitta only after rectifying the deficiencies noted, vide paper read (4).

- 5. The same was intimated to the college and the college has submitted the complaince report, vide paper read(5&6) above.
- 6.The Compliance report was scrutinised by the Scrutiny Committee and recommended to grant Continuation of Provisional Affiliation to the college for the academic year 2022-23, vide paper (7) above.
- 7. Considering the recommendation of the Scrutiny Committee, the Hon'ble Vice Chancellor accorded permission to grant Continuation of Provisional Affiliation to Mount Zion Medical College Hospital, Pathanamthitta for the academic year 2022-23 and to intimate the name of the college to the CEE, as the already allotment process was on. The list was the CEE sent to 8. The 72nd meeting of the Governing Council, vide decision No.72.06 has resolved to ratify the action of the Hon'ble Vice Chancellor in having granted Continuation of Provisional Affiliation to Mount Zion Medical

College Hospital, Pathanamthitta for the academic year 2022-23 and forwarding the same to DME/CEE vide paper read(8) above.

9. Accordingly, orders are issued granting sanction for the Continuation of Provisional Affiliation to Mount Zion Medical College Hospital, Pathanamthitta for conducting the following courses with an annual intake of students mentioned against each during the academic year 2022-23 subject to the conditions detailed below :-

2	MS Orthopaedics	1

- Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for
  continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with
  a copy of letter of approval from the apex bodies concerned.
- The College should remit annual administration fee fixed for UG/PG course for the academic year 2022-23.
   The College shall produce the orders regarding the constitution of College Council for the academic year 2022-23 during the time of student data verification.
- · Admission to the next academic year shall be made only after obtaining prior permission from the University.
