ORDER

University vide read (1) above invited applications for Continuation of Provisional Affiliation for the Academic year 2021-22. In response to the notification, vide read (2) above, the Principal, Mount Zion Medical College, Pathanamthitta had submitted application for Continuation of Provisional Affiliation for the Academic year 2021-22.

2. The inspection commission conducted inspection at the college and submitted inspection report which was examined by the scrutiny committee. The committee, vide read (3) above, pointed out grave deficiencies in Faculty, Residents and Clinical materials. These deficiencies were intimated to the college vide read (4) above and subsequently, the Principal submitted compliance report vide read (5) above and was examined by the scrutiny committee vide read (6) above. The committee pointed out deficiency of one faculty in the Department of Pulmonary Medicine which is within the permissible limit as per NMC guidelines.

4. Vide the Notification read (7) above, the college has obtained recognition from the Ministry of Health and Family Welfare Department, Govt. of India for conducting MBBS course with 100 seats.

5. Considering the fact that the deficiency is within the permissible limit as per NMC guidelines and the allotment process for the MBBS course by the Commissioner of Entrance Examinations is due soon, sanction has accorded to grant Continuation of Provisional Affiliation to the Mount Zion Medical College, Pathanamthitta for conducting **MBBS course with 100 seats** for the **academic year 2021-22** subject to ratification by the Governing Council and the conditions detailed below:

1. The Deficiency of one Professor in the Department of Pulmonary Medicine pointed out by the Scrutiny Committee shall be rectified at the earliest and reported to the University.
2. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
3. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.





4. Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned. The college should rectify all the deficiencies noted during the last inspection and should submit the compliance to the University urgently.
5. The College should remit annual administration fee fixed for UG/PG /Super Specialty courses for the academic year 2021-22 and **the college should submit the order reconstituting the College Council for the Academic year 2021-22 at the time of Student Registration .**
6. Admission to the next academic year shall be made only after obtaining prior permission from the University.

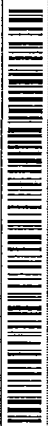
